TERMS OF SALES

1 - Reservation:

All reservations must be accompanied by a deposit of 25% of the amount of the stay for rentals and 30% for locations. To this amount add the booking fee of 9 € in high season.

The reservation becomes effective with our agreement, after receipt of the deposit (booking fees included) and after acceptance of the general conditions of sale when booking online.

The booking of a camping pitch or rental is strictly personal. Under no circumstances can you sublet or transfer your reservation without the prior consent of the campsite.

2- Payment:

For accommodation rentals, the payment of the stay must be paid no later than 30 days before arrival. If the payment does not reach us within this period, the rental will be canceled according to the conditions of cancellation hereafter.

For camping-caravanning reservations, the balance of the stay must be paid on the day of arrival.

3 - Guarantees (only for rental accommodation):

A deposit of 300 € is required upon arrival and will be returned on departure after the inventory, under

reserve deteriorations or additional cleaning if the cleanliness is deemed insufficient by the responsible, the cleaning fee of 50 € will be deducted from the deposit.

4 - Arrival, departure:

Accommodation will be available from 4 pm on the day of arrival and must be vacated no later than 10 am on the day of departure.

The campsite will be available from 1 pm on the day of arrival and must be vacated no later than 12 pm on the day of departure. No reduction will be granted in the case of delayed arrival or early departure.

5 - Cancellation and Modifications:

All cancellations must be notified 30 days before the date of arrival (The postmark will be taken as proof). However, a lump sum of 22 € will be deducted for cancellation fees. After this period, whatever the reason for cancellation, no refund of deposit will be made. In the absence of a message from the renter indicating a postponement of the date of arrival, the accommodation or the location may be available again for sale 24 hours after the arrival date mentioned on the contract, and will lose accordingly the benefit of his reservation.

Changes to a reservation may be made subject to availability and as long as the capacity of the accommodation / rental location allows. Otherwise, the Management will be obliged to terminate the contract.

We invite you to take out cancellation / interruption insurance when booking. Our partner Gritchen Affinity will reimburse all or part of the stay to customers who have purchased Campez Couvert insurance (subject to conditions)

In case of cancellation, notify the campsite of your withdrawal upon the occurrence of an event preventing your departure by mail or email. If the claim is provided in the general conditions

(available on the website www.campez-couvert.com or from the campsite), notify the insurer within 48 hours and provide all the necessary information and supporting documents.

6 - Inventory - inventory (only for rental accommodation):

On arrival, the inventory and inventory will be checked by the tenant. No claim will be taken into consideration after 8 pm on the day of arrival.

Initially, the inventory will be made by us in the presence of the tenant on the day of departure between 8am and 10am.

For all departure before 8am, the deposit will be returned by mail, subject to damage or additional cleaning, within 7 days after inventory made by us.

7 - Insurance:

The tenant must be covered by third party liability insurance to cover any damage. Management disclaims all liability in the event of theft, fire or other incident.

8 - Animals:

Pets are allowed in the campsite and rental accommodation (except Chalet Fabre model).

Only one dog under 15 kg will be allowed per rental. In addition, will not be accepted to stay on the campsite, only animals not classified dangerous, necessarily tattooed (or microchip), vaccination book mandatory. The animals must be leashed inside the campsite and accompanied outdoors for cleanliness. They must not inconvenience the neighborhood by barking or staining, or be alone in the rental or location.

9 - Regulation:

Clients undertake to respect the rules of the campsite posted at the reception, under penalty of being excluded from the latter, for the well-being and respect of other campers.

10 - Jurisdiction clause:

The courts of Digne-les-Bains are only competent in case of litigation. Only the French version is authentic.
